#### HIGHER EDUCATIONAL AIDS BOARD BOARD REPORT #04-05 STUDENT AID EXPENDITURES FOR 2002-03

### ACADEMIC EXCELLENCE SCHOLARSHIP

Academic Excellence Scholarships are awarded to high school seniors who have the highest cumulative grade point average in each public and private high school throughout the state of Wisconsin. The number of scholarships for which each high school is eligible is based on total student enrollment. In order to receive a scholarship, a student must enroll full-time by September 30 of the year in which the student graduated from high school, at a participating University of Wisconsin, Wisconsin Technical College, or Independent institution in the State of Wisconsin. The scholarship is applied to the student's tuition, in the amount of \$2250 per year, for up to four years. Half of the scholarship is funded by the State, while the other half is matched by the institution.

The total dollars expended for this program increased by over two percent in 2002-03 compared to 2001-02. The number of awards increased from 2,781 in 2001-02 to 2,851 in 2002-03. The average award decreased from \$1,086 to \$1,083.

In 2002-03 the majority of recipients attended University of Wisconsin schools (82.30 percent).

### HANDICAPPED STUDENT GRANT

The Handicapped Student Grant Program was established to provide funding for Wisconsin residents, enrolled at an in-state or eligible out-of-state public or independent institution who show financial need and have a hearing or visual impairment. Students are eligible to receive up to \$1,800 per year for up to five years.

The total dollars expended for this program in 2002-03 decreased by 10.5 percent compared to 2001-02. The number of recipients decreased by 5 awards in 2002-03 compared to 2001-02. The average award decreased from \$1,574 to \$1,537. Every student who applied and met eligibility criteria received an award. HEAB plans to make extra efforts this year to further publicize the award in all available venues.

Students attending school within the WTC System used 57.45 percent of the funding, UW System students used 24.89 percent and independent colleges and universities used 15.80 percent.

#### **INDEPENDENT STUDENT GRANT**

The Independent Student Grant provided funding to resident undergraduate students who were recipients of Aid to Families with Dependent Children (A.F.D.C.). Awards were based on financial need. Recipients of the grant who no longer reside in Wisconsin or who have not successfully completed requirements for a degree or certificate within five years of receiving this grant are required to repay the grant amount. Beginning with the academic year 1997-98, funding ended under this program per statutory change and no new grants have been made since that time. Of the students who received funding under this program, the majority (over 81 percent) are either forgiven or paid in full.

#### INDIAN STUDENT ASSISTANCE GRANT

Awards under this program are made to Wisconsin residents who are at least twenty five percent Native American and are undergraduate or graduate students enrolled at least half time in degree or certificate programs at University of Wisconsin, Wisconsin Technical College, Independent Colleges and Universities or Proprietary Institutions throughout Wisconsin. Awards are based on financial need with a limit of ten semesters of eligibility. HEAB has an informal matching arrangement with grant funds awarded by the Federal Bureau of Indian Affairs and Wisconsin Tribal governments.

The total dollars expended in 2002-03 increased from 2001-02 by 6.7 percent. The number of recipients increased by 7 percent. The average award decreased from \$915 in 2001-02 to \$912 in 2002-03.

The 2002-03 academic year was the seventh year that the maximum grant a student could receive under this program was \$1,100. Prior to 1995-96 the maximum grant was \$2,200. In 1999-00, the funding source for this program was changed from General Program Revenue (GPR) to (PR) gaming revenues.

#### MINORITY UNDERGRADUATE RETENTION GRANT

Awards under this program are made to resident minority undergraduates, excluding first year students, enrolled at least half-time at Independent, or Wisconsin Technical Colleges, and tribal colleges. According to the statutes, a minority student is defined as a student who is either a Black American, American Indian, Hispanic, or Southeast Asian admitted to the U. S. after December 31, 1975. Awards are based on financial need with a maximum grant of \$2,500 per year for up to eight semesters or twelve quarters. The University of Wisconsin System Administration has a similar program, the Lawton Grant, for students attending those institutions.

The total dollars expended by students from both systems in 2002-03 increased by two percent compared to 2001-02. The number of recipients increased by almost one percent. The average

award (for both sectors) increased from \$1,158 in 2001-02 to \$1,168 in 2002-03. The majority of recipients for the Minority Undergraduate Retention Grant continue to be African American.

### MINORITY TEACHER LOAN

The Minority Teacher Loan Program provides loans at five percent interest of up to \$2,500 per year to a maximum of \$5,000 to resident, minority, undergraduate students who are enrolled at least half-time in programs leading to teacher licensure at an Independent or University of Wisconsin Institution. The student who participates in this program must agree to teach in a school district located in the state in which minority students constitute at least twenty nine percent of total enrollment or in a school district participating in the interdistrict pupil transfer (Chapter 220) program. If the student does not teach in an eligible district, the loan must be repaid.

In 2002-03, the total dollars expended increased by almost one percent. The average award increased from \$2,190 in 2001-02 to \$2,222.

In 1999-00, due to administrative rule changes, this program became available to students attending school at least half-time rather than at least full-time and students are no longer required to show financial need in order to be considered for this program.

Under the forgiveness component of this program, out of 901 borrowers, over 41 percent are either forgiven or paid in full. An additional 31 percent are either in forgiveness or repayment. Twelve percent are still enrolled at least half-time in school.

#### NURSING STUDENT LOAN

The Nursing Student Loan program provides education loans at five percent interest up to \$3,000 per year. This loan may be used by Wisconsin resident students who are enrolled at least halftime in a UW, Wisconsin Technical or private, non-profit post secondary institution in the state leading to a nursing license. For each of the first two years the student nurses and meets the eligibility criteria, 25% of the loan is forgiven. The balance remaining after forgiveness must be repaid at an interest rate not to exceed 5%. If the student does not practice nursing or meet the eligibility criteria, the loan must be repaid at an interest rate not to exceed 5%.

The total dollars expended the first year of this program was \$449,499 with 327 awards. The average award was \$1,375. The majority of the recipients attended Wisconsin Technical Colleges (52.44 percent).

#### NURSING STUDENT STIPEND LOAN

The Nursing Student Stipend Loan was established to fund full-time, undergraduate, Wisconsin resident, nursing students with financial need. Beginning with the 1995-96 academic year a provision was added to the 1995 Act 27 which prohibits any new students from participating in this forgivable loan program. Of the students who received funding under this program, the majority (over 86 percent) are currently in forgiveness status, forgiven in full or paid in full.

#### PAUL DOUGLAS SCHOLARSHIP

The Paul Douglas Scholarship was developed to provide funding for students who graduated in the top ten percent of their high school class and are in training to become teachers. This forgivable loan program (although referred to as a scholarship) funded by the federal government and administered by HEAB was repealed in 1995-96. Of the 213 students who received funding under this program, more than 72% have been forgiven, are in forgiveness status or have paid in full.

#### TALENT INCENTIVE PROGRAM GRANT

The Talent Incentive Program (TIP) Grant provides grant assistance to the most financially needy and educationally disadvantaged Wisconsin resident students attending colleges and universities in the State of Wisconsin. First-time freshmen students are nominated for the TIP Grant by the school financial aid offices or by counselors of the Wisconsin Educational Opportunities Program (WEOP). To continue to receive the TIP Grant, students must be enrolled consecutive terms and continue to show financial need. Eligibility cannot exceed ten semesters.

Both the State of Wisconsin and the Federal Government provide funding for the TIP Grant. \$5,978,126 was expended in 2002-03, of which \$1,396,427 was federal funds. The number of awards in 2002-03 increased by over six percent compared to 2001-02. The average award increased from \$1,268 in 2001-02 to \$1,296 in 2002-03. Dependent students (64 percent) utilized the majority of the funds.

#### **TEACHER EDUCATION LOAN PROGRAM**

The Teacher Education Loan Program provides loans to Wisconsin residents enrolled in the teacher education programs at the Milwaukee Teacher Education Center (MTEC). The student who receives this loan must agree to teach in the Wisconsin school district operating under Chapter 119 of the Wisconsin State Statutes, First Class City School System (currently only the Milwaukee Public Schools). For each year the student teaches in the eligible school district, 50% of the loan is forgiven. If the student does not teach in the eligible district, the loan must be repaid at an interest rate of 5%.

The total dollars expended in 2002-03 increased by thirteen percent from 2001-02. The total number of awards increased by almost nine percent. The average award decreased from \$1,765 in 2001-02 to \$1,616 in 2002-03.

At the end of the 2002-03 academic year, 193 recipients were forgiven-in-full, 347 were in forgiveness and 16 recipients were in repayment.

### TEACHER OF THE VISUALLY IMPAIRED LOAN PROGRAM

The Teacher of the Visually Impaired Loan Program provides loans to Wisconsin residents who are enrolled at least part-time at an in-state or eligible out-of-state institution in a program that prepares them to be licensed as teachers of the visually impaired or as orientation or mobility instructors. The maximum award per year is \$10,000 with an overall maximum of \$40,000. The student who participates in this program must agree to be a licensed teacher or an orientation or mobility instructor in a Wisconsin School district, the Wisconsin Center for the Blind and Visually Impaired or a cooperative educational service agency. For each of the first two years the student teaches and meets the eligibility criteria, 25 percent of the loan is forgiven. For the third year, 50 percent is forgiven. If the student does not teach and meet the eligibility criteria, the loan must be repaid at an interest rate of 5 percent. This program was established in May of 2000. The first awards were made in the 2000-01 academic year.

In its third year of existence, the program made thirteen awards totaling \$85,946. This is an increase from seven awards for \$30,880 in 2001-02. The average award was \$6,611. Eight awards were made to students at an in-state school and five were made to an out-of-state school.

#### WISCONSIN HIGHER EDUCATION GRANT

The Wisconsin Higher Education Grant Program provides grant assistance to undergraduate, Wisconsin residents enrolled at least half time in degree or certificate programs at University of Wisconsin, Wisconsin Technical College institutions and Wisconsin Tribal College institutions. Awards are based on financial need. Eligibility cannot exceed ten semesters.

The total dollars expended for the WHEG - UW System increased by over fourteen percent compared to 2001-02. The average award for a student attending a University of Wisconsin in 2001-02 was \$1,012. In 2002-03 the average award increased to \$1,160. The number of recipients increased from 19,149 in 2001-02 to 20,505 in 2002-03.

The total dollars expended for the WHEG - WTC System increased by just over 1 percent compared to 2001-02. The average 2001-02 award for a student attending a Wisconsin Technical College was \$699. In 2002-03 the average award increased to \$714. The number of recipients decreased from 20,246 in 2001-02 to 20,112 in 2002-03.

The total dollars expended for the WHEG - Wisconsin Tribal Colleges increased by almost one percent compared to 2001-02. The average award for a student attending a tribal college was

\$1,418 in 2002-03 compared to \$1,379 in 2001-02. The number or recipients decreased from 290 in 2001-02 to 284 in 2002-03. 2002-03 was the fourth year of existence for this grant program. It is funded by tribal gaming revenues.

In 2002-03 the total funds expended under the WHEG program (by the three systems) was \$36,985,843. In 2001-02 the total expended under the WHEG program was \$33,937,780.

Dependent students attending a University of Wisconsin institution in 2002-03 received the majority of the funds available, 56.05%. This compares to almost 55 percent in 2001-02. Their average award was \$1,043 compared to the \$1,200 average award received by independent students with families and the \$1,081 average award received by single, independent students.

Independent students with families attending a Wisconsin Technical College in 2002-03 received the majority of the funds available, over 59 percent. Their average award was \$777 compared to the \$637 average award received by single independent students and the \$637 average award received by dependent students.

Independent students with families attending tribal colleges in 2002-03 received the biggest share of the funds available (over 72 percent). This compares to over 82 percent in 2001-02. Their average award was \$1,478 compared to the \$1,321 average award received by single independent students with families and the \$1,221 average award received by dependent students.

#### WISCONSIN TUITION GRANT

The Wisconsin Tuition Grant Program provides grant assistance to undergraduate, Wisconsin residents enrolled at least half time in degree or certificate programs at non-profit Independent Colleges or Universities throughout Wisconsin. Awards are based on financial need and partially based on the portion of tuition in excess of UW - Madison tuition. Grants range from \$250 to \$2,350 for the current academic year. Eligibility cannot exceed ten semesters.

Total funds spent under the Wisconsin Tuition Grant Program increased by six percent from 2001-02 to 2002-03. The number of recipients increased from 11,089 in 2001-02 to 11,673 in 2002-03. The average award increased from\$1,907 in 2001-02 to \$1,922 in 2002-03.

Dependent students received the majority of the funds available in 2002-03 (almost 75 percent) while their average award was \$2,065 compared to the \$1,478 average award for single independent students and the \$1,707 average award for independent students with families.
