ELECTION OF 2011-2012 BOARD OFFICERS:

BOARD REPORT #12-04 STATUS OF 2011-12 APPLICANTS AND PROGRAMS

In 2011-12, WHEG-UW has committed 147.49% (\$86,055,149) of its appropriation with 41,407 awards. This is 6,151 more awards and 17.38% more committed than at this time last year. WHEG – WTC has committed 154.60% (\$29,061,721) of its appropriation with 26,263 awards. This is 3,921 less awards and 9.94% less committed than at this time last year. WTG has committed 138.71% (\$37,271,563) of its appropriation with 13,288 awards. This is 1623 fewer awards and 13.83% less committed than at this time last year. WHEG – Tribal has committed 121.46% (\$551,681) of its appropriation with 329 awards. This is 1 less award and 4.84% more committed than at this time last year. The number of applicants (first-time FAFSA filers who listed Wisconsin as their state of legal residence) for 2011-12, through October 24, 2011, is 332,779. Last year at this time there were 326,907 applicants.
