Thank you for including WAICU's recommendation for student aid in the development of HEAB's 2013–2015 biennial state budget.

### **Principles**

WAICU embraces HEAB's 1968 policy framework: specifically, that taxpayer-funded student aid should be allocated to <u>Wisconsin</u> students with documented need attending a <u>Wisconsin</u> public or private nonprofit college or university. In these times of economic distress, Wisconsin's competitiveness in the "Knowledge Economy" is dependent on growing the educational attainment of our workforce. Our future is dependent upon investment targeted at increasing the educational attainment of all Wisconsin citizens. WAICU also endorses the consensus of the Legislature and of the 2112 Commission on Financial Aid Consolidation and Modernization that the eligibility for HEAB-administered aid programs should not be expanded beyond the student populations they currently support.

### Creating Consistency and Security for Students over their College Careers

The 2012 Commission on Financial Aid Consolidation and Modernization has not yet completed its work. However, WAICU is supporting in the Commission and to HEAB that it renew its support in its budget for a statutory link between tuition increases and student aid appropriations and for sum sufficient appropriations for WTG and MURG, WHEG-UW and Lawton, WHEG-WTCS, and for WHEG-Tribal. As students increasingly transfer among 2– and 4–year public and private, nonprofit institutions, equitable funding becomes essential for increasing degree completion. There already is a precedent for linking WTG funding to UW-Madison tuition: the statutory WTG formula in s. 39.30 for determining individual students' annual WTG awards includes UW-Madison tuition as one of its factors.

We believe the best way to equitably advance educational opportunity in Wisconsin is embodied in the language of 2005 Assembly Bill 743 (attached). WAICU's recommendation is that the HEAB Board adopt the provisions of this legislation as part of its budget submission.

ROLF WEGENKE, Ph.D. President Specifically, the provisions in the 2005 legislation increase the appropriations for each of HEAB's major need-based grant programs by the greater of the following two amounts:

- Increase each grant's prior year appropriation by an amount equal to by the average percentage by which the undergraduate academic fees that will be charged for the next academic year at each institution within the UW System, as estimated by HEAB, will increase from the undergraduate academic fees charged for the current academic year;
- Increase each grant's prior year appropriation by an amount equal to the dollar increase in UW tuition multiplied by the number of students who will be receiving the respective grants for the next academic year, as estimated by the HEAB board.

WAICU understands that President Reilly of the UW System, President Clancy of the Wisconsin Technical College System, and President Fowler of the College of Menominee Nation also will be making budgetary recommendations for the consideration of the Board. Additionally, the 2012 Commission will make recommendations. WAICU will continue the tradition of deference to our sister institutions—always putting the best interests of the <u>Wisconsin</u> students first. If the WAICU recommendation is inconsistent with the recommendations of the other sectors, the board could simply adopt the 2005 AB 743 language for the WTG and the MURG only.

### Specific Budget Recommendations-WTG and MURG

As you know, the student financial aid appropriations were flat-funded for the 2011-13 biennium. While we are thankful that these funds were not cut, the financial need of students has only grown over time due to the recession. In a single year, 2009-10, Wisconsin the population of students whose parents can effectively pay nothing – zero – toward the cost of their education grew by 50 percent.

Using the proposed formula recommended above by applying the recently-recommended UW tuition increase of 5.5 percent, WAICU is recommending an increase in the WTG of \$1,477,900 in FY13–14 and \$3,037,100 for FY14–15 to increase funding for the WTG by 5.5 percent in each year of the biennium. Total funding for the WTG would increase from \$26,870,300 in 2011-12 (and 2012-13) to \$28,348,200 in 2013–14 and \$29,907,400 in 2014–15. Additionally, incorporating the same methodology, as we understand it, used by UW System and passed by the UW Board of Regents, to incorporate "catch-up" into their request, WAICU requests "catch-up" for the biennium of \$3,204,140 for 2013-14 and \$3,380,368 for 2014-15, bringing the total Tuition Grant appropriation request to \$31,552,340 for 2013-14 and \$33,287,768 for 2014-15.

WAICU also recommends an increase in the Minority Undergraduate Retention Grants program (MURG) of \$45,000 in FY13–14 and \$92,500 in FY14–15 to increase funding for the MURG by 5.5 percent in each year of the biennium. Total funding for the MURG would increase from \$819,000 in 2011-12 (and 2012-13) to \$864,000 in 2013–14 and \$911,500 in 2014-15. Using an identical "catch-up"

methodology means an additional \$97,588 for 2013-14 and \$102,955 for 2014-15, with a total request for that appropriation of \$961,588 in 2013-14 and \$1,014,455 in 2014-15.

The 23 nonprofit private colleges and universities of Wisconsin and their 61,000 students are united in support of this recommendation. ### Analysis by the Legislative Reference Bureau

Under current law, the Higher Educational Aids Board (HEAB) provides higher education grants to Wisconsin residents who are enrolled in the University of Wisconsin (UW) System, a technical college, or a tribal college and tuition grants to Wisconsin residents who are enrolled in accredited, nonprofit post-high school, educational institutions in this state. The Board Regents of the UW System provides grants, known as Lawton grants, to minority undergraduates enrolled in the UW System.

#### ASSEMBLY BILL 743

Currently, sum certain amounts are appropriated in each fiscal year for tuition grants and for higher education grants for technical college and tribal college students. For higher education grants for UW System students, beginning in fiscal year 2005-06, there is appropriated a sum sufficient equal to the amount appropriated for those grants in the previous fiscal year (base amount) increased by the highest percentage increase in undergraduate academic fees among the institutions within the UW System between the current and previous academic years, except that, if the undergraduate academic fees at each institution within the UW System for the current academic year did not increase from the previous academic year, the appropriation for the current fiscal year remains the base amount. The same formula is also used to calculate the amount appropriated for Lawton grants.

This bill changes the formula used to calculate the amounts appropriated for higher education grants for UW System students and for Lawton grants. The bill also requires HEAB to use the new formula to calculate the amounts appropriated for tuition grants and for higher education grants for technical college and tribal college students. Specifically, under the bill, beginning in fiscal year 2006-07, the amounts appropriated for tuition grants, for Lawton grants, and for higher education grants for UW System students, technical college students, and tribal college students are determined by increasing the base amount for each of those appropriations by the greater of the highest percentage increase determined under current law or the amount obtained by multiplying the increase in the undergraduate academic fees charged for a student to attend the UW-Madison for the current academic year over the previous academic year by the number of students who received the respective grants for the previous academic year, except that, if the undergraduate academic fees at each institution within the UW System did not increase from the previous academic year, the appropriations for the current fiscal year remain the base amounts.
